Meeting Minutes

Tuesday, December 13, 2011

Call to Order at 5:45pm

I. Fundraising

Mabel's Labels: Ginger informed members that the Mabel's Label fundraiser netted a check in the amount of \$118.80.

Hey Baby!: Ginger stated that Team Spirit had over \$2,166 in sales, and should be receiving a check for just over \$500. Discussion took place regarding the sales from the trunk show and how the funds received should be credited to the accounts. Although it was decided in the November meeting that all proceeds from trunk show sales would go to the general fund, there was confusion about individuals that placed all of their orders the night of the trunk show to receive them in time for Christmas.

A motion was made to amend the previous decision with regard to credit for Hey, Baby sales to the following:

"Proceeds from purchases made by TS parents / families will be credited to their athlete(s). Proceeds from orders not associated with a particular family will go to the general fund."

With all in favor, the motion was approved.

Electronics Recycling: Jamie Williams informed members that the Electronics Recycling Fundraiser earned \$28.75 for the first load of items mailed. She added that the fundraiser will be ongoing throughout the season, and that the collection box will remain in the cheer gym. She reminded members that the funds earned from the recycling fundraiser are going to the general fund.

II. Photos

Jodi Bennett advised members that the photo day has been postponed until uniforms arrive. She added that as soon as they have a concrete ship date, they will reschedule photos.

III. Team Bonding / Special Events

Parent Spirit Day / Team Spirit Live: Cynthia Flanagan requested reimbursement for supplies and refreshments purchased for the parent spirit day and team showcase. Motion was made to grant Cynthia Flanagan a reimbursement check in the amount of \$200.

With all in favor, the motion was approved.

Holiday Party: Cynthia reminded members that the holiday party is scheduled for Tuesday, December 20th and will be held at the home of the Kaplan Family. Lynne Kaplan provided directions to be distributed to TS athletes and families. Sarah Renner volunteered to create an invite to send to families with event specifics. Activities at the event will include the pot luck meal, spirit cowbell decorating, and ornament making. Lynne Kaplan requested that members bring any ribbons, feathers, etc. they have to contribute towards decorating the cowbells and ornaments.

Discussion took place regarding the gift exchange. It was decided that only the team gift exchange would take place, and big sis/lil sis gift exchange would not. Members present reviewed the pot luck sign up sheet and added additional items as needed. A reminder email will go out to all athletes and families to have them sign up for their contribution.

TS Showcase: Coach K stated that the showcase went well and thanked booster club members for their contributions of refreshments for the event.

Hairbows: Coach K informed members that the hairbows for the Mini and Senior teams had arrived, but that the bows for the Tiny team had not.

Parent Cheer: Coach K announced that the coaching staff would like for families to learn a short spirit chant to be used at competition to show support to the TS athletes. Words to the chant are: "Team _ Spirit _ XX-XXX!" (_ denotes a pause, X denotes a clasp.)
